SUBJECT: Resolution 2019-089 Approve Street Closures for Rock Island Ramble

Background:

Tonya Dunn has contacted me regarding hosting the Rock Island Ramble Bicycle Ride on Saturday, August 3, 2019, beginning at approximately 9:30 AM.

The ride will begin at the Depot, continue to the Faribault Country Club, then to Warsaw and return to Faribault ending at the Depot. The route will be almost entirely on the trail except for crossing 14th Street NE and the section from North Alexander Park to Hulett Avenue. Cones will be used on the shoulder of 20th Street NW to designate the bike path in that area. A completed indemnity agreement including insurance information will be provided prior to the event.

Recommendation:

Approve Resolution 2019-089 to intermittently close the listed roads for the Rock Island Ramble on August 3, 2019.

WHEREAS, Rock Island Ramble Bicycle Ride is being held on Saturday, August 3, 2019, and;

WHEREAS, the Faribault City Council is supportive of these events, and

WHEREAS, Section 15-57 of the Faribault Code of Ordinances provides for temporary parking restrictions by means of Council resolution,

NOW, THEREFORE, BE IT RESOLVED that locations will be intermittently closed on Saturday, August 3, 2019, beginning at approximately 9:30 AM to allow for the Rock Island Ramble. The ride will begin at the Depot, continue to the Faribault Country Club, then to Warsaw and return to Faribault ending at the Depot. The route will be almost entirely on the trail except for crossing 14th Street NE and the section from North Alexander Park to Hulett Avenue.
