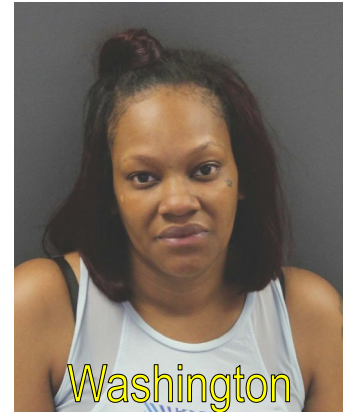

Helmet Hide

On Thursday, August 24th, agent of the **Cannon River Drug and Violent Offender Task Force** executed a search warrant at a Faribault residence. The agents were assisted by **Detective Scott Duncan, Sergeant Brandon Gliem, RCSO Deputy Trevor Peterson, LeSueur County SO Deputy Jim Whiteis**. Inside, the agents found evidence of cocaine sales, including a digital scale with cocaine residue. The agents noted the items were within reach of children inside the residence. In the garage, the agents found a scooter regis-

tered to the suspect. Inside a nearby motorcycle helmet, the agents found a plastic container typically used to hide narcotics. Inside the container was a baggie of suspected crack cocaine. The suspect, Charlotte Washington, 35, was arrested and jailed. She was charged with 3rd degree Controlled Substances and Child Endangerment. Her bail was set at \$2,000 with conditions. Four children in the residence were removed and placed with a family member.

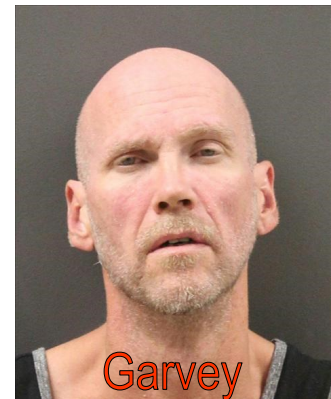

DWI Arrest

Speaking of DWI enforcement, on Thursday, August 31st, **Officer Mallory House** observed a vehicle without operable taillights. She also noted the license plates did not match the vehicle. She stopped the vehicle and met with the driver, who displayed signs of alcohol impairment. The driver, Linster Garvey, 44, failed several roadside sobriety tests and was arrested. At the jail, he submitted to a breath test which re-

ported a .08 blood alcohol concentration. Garvey was cited for 3rd degree DWI and Driving After Cancellation - Inimical to Public Safety, Displaying Incorrect License Plates, No Proof of Insurance. He was released on his own recognizance by the court.

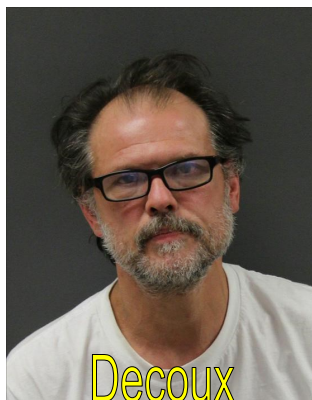
Warrant Watch

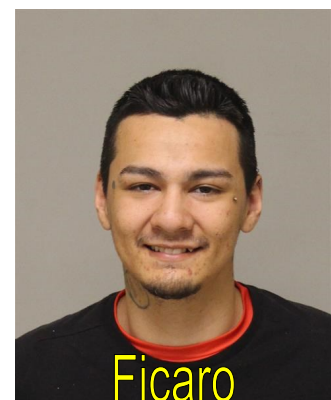
