SUBJECT: Traffic Study Requests

Background:

Four (4) requests have been received for the installation of additional 15-Minute Parking stalls in the Downtown Area at the following locations:

- 224 Central Avenue
- 227 Central Avenue
- 302 Central Avenue (two requests)

The first request, at 224 Central Ave., is for a 15-Minute Parking space by or next to the handicap accessible stall on the corner of Central Ave. and 3rd St. NW by Pawn MN and Keepers Antiques. The request is to help with the flow of parking on the block. There are four 15-Minute Parking stalls within one-half block of the requested location. The installation of an additional 15-Minute parking stall is not recommended.

The second request, at 227 Central Ave., is for one 15-Minute Parking stall in front of the location on Central Ave. There are two 15-Minute Parking stalls around the corner on 3rd St. NE and four 15-Minute Parking stalls at the midblock of Central Ave. The installation of an additional 15-Minute Parking stall is not recommended.

The third request at, 302 Central Ave., is for the installation of two 15-Minute Parking stalls alongside the Security Bank Building on 3rd St. NW. There are two 15-Minute Parking stalls on 3rd St. NW across the street to the south from this location and two 15-Minute Parking stalls at the midblock of 3rd St. NW. Additionally, there are four 15-Minute Parking stalls one-half block to the north on Central Ave. The installation of additional 15-Minute Parking stalls is not recommended.

The fourth request, at 302 Central Ave., is for the installation of one 15-Minute Parking stall next to the handicap accessible stall on Central Ave. and two 15-Minute Parking stalls alongside of the Security Bank Building on 3rd St. NW. There are two 15-Minute Parking stalls on 3rd St. NW across the street to the south from this location and two 15-Minute stalls at the midblock of 3rd St. NW. Additionally, there are four 15-Minute Parking stalls one-half block to the north on Central Ave. The installation of additional 15-Minute Parking stalls is not recommended.

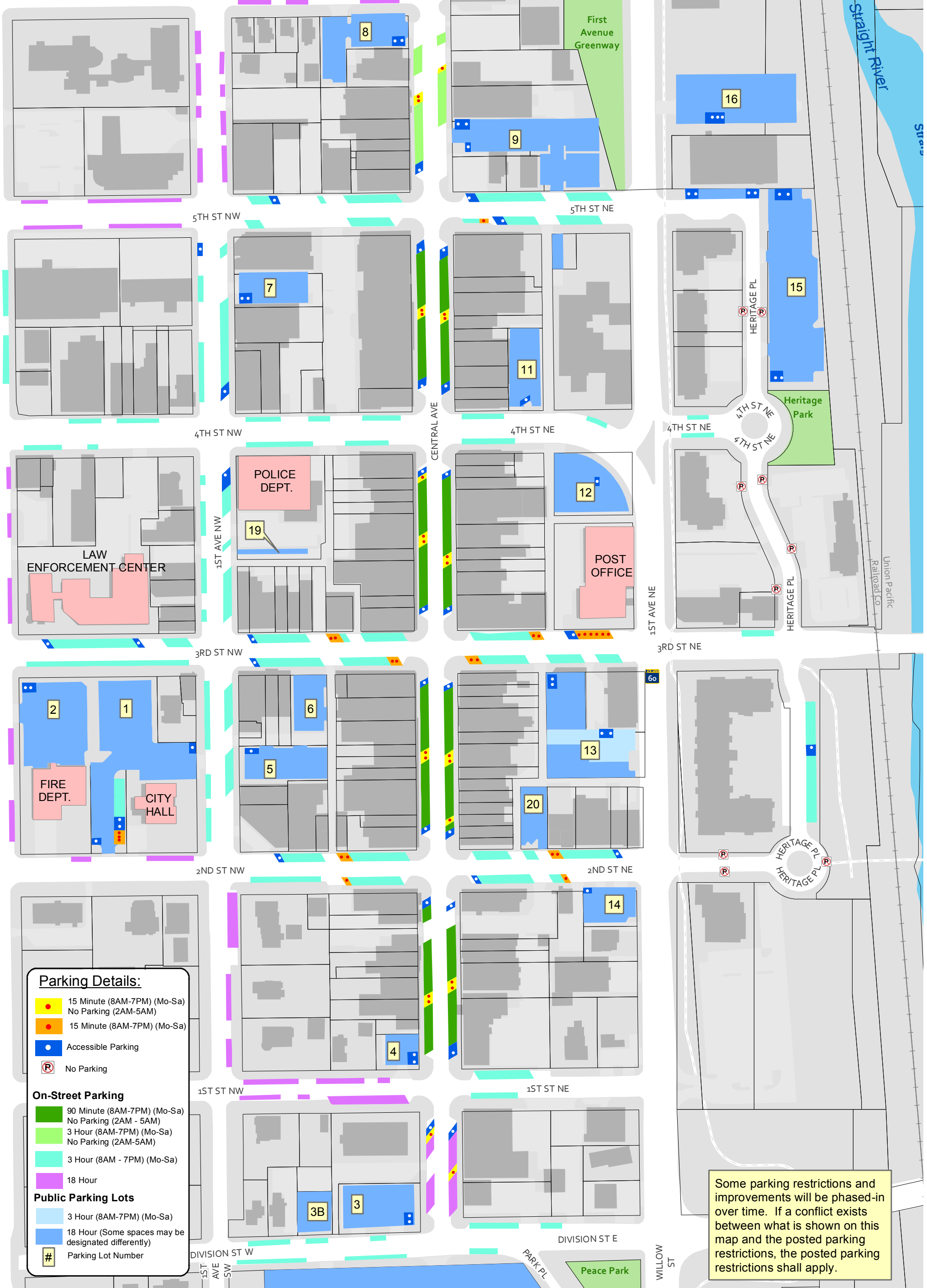
