Background:

On November 3, 2020, a General Election was held for Mayor and three seats for City Council Members. Section 2.03 (Council Composition and Election) of the Charter states that each Council member shall serve for a term of four years and until a successor is elected and qualifies.

Each election cycle, the official Election Abstract is completed by Rice County Property Tax and Elections. This year, Rice County is able to count ballots postmarked on November 3, 2020 for seven days after the election. Due to the extended counting time, the Abstract will not be completed until November 12, 2020.

The newly elected Mayor and Council Members terms will begin the first Monday of January 2021.
