### Background:

A request has been made by the Paradise Center for the Arts, on behalf of the Blue Collar BBQ & Arts Festival Committee, to close the 100, 200, 300 & 400 Blocks of Central Avenue on Saturday, August 10, 2019. They will also close 3<sup>rd</sup> Street from Central Avenue halfway to 1<sup>st</sup> Avenue NE and halfway to 1<sup>st</sup> Avenue NW (from alley to alley). The request is to close these streets from 6AM on Saturday, August 10, to 1AM on Sunday, August 11, 2019. They have acknowledged allowing access during the festival to other entities if needed for handicap or other reasonable needs.

**WHEREAS**, the Paradise Center for the Arts is sponsoring multiple community events August 10, 2019; and

WHEREAS, the Faribault City Council is supportive of these events; and

**WHEREAS**, the Paradise Center for the Arts will provide a completed event agreement including liability insurance information prior to the event; and

**WHEREAS**, Section 15-57 of the Faribault Code of Ordinances provides for temporary parking restrictions by means of Council resolution.

**NOW, THEREFORE, BE IT RESOLVED,** that the 100, 200, 300 and 400 blocks of Central Avenue will be closed from 6:00 AM on Saturday, August 10, 2019, to 1:00 AM on Sunday, August 11, 2019, for BBQ food vendors, artist vendors, youth events, live music and beer tent.

**ALSO, BE IT RESOLVED,** that 3<sup>rd</sup> Street will be closed from Central Avenue halfway to 1<sup>st</sup> Avenue NE and halfway to 1<sup>st</sup> Avenue NW (from alley to alley) from 6:00 AM on Saturday, August 10, 2019, to 1:00 AM on Sunday, August 11, 2019.
