### **Background:**

Wednesday, March 18, 2020 bids were received for the proposed 2020 13<sup>th</sup> Street NW Extension Improvements – Contract 2020-05, including construction of curb and gutter, concrete sidewalk, storm sewer, sanitary sewer, watermain, bituminous paving, pavement markings, and related improvements.

The streets proposed to be included in this project are as follows:

13<sup>th</sup> Street NW (Western Avenue to 600 ft East of Western Ave)

The bids are tabulated as follows:

BCM Construction, Inc.	\$234,244.50
R.A.W. Construction	\$271,905.50
James Bros. Construction, Inc.	\$304,236.90
Alcon Construction Co.	\$304,300.00
Schumacher Excavating Inc.	\$315,244.45
Kuechle Underground, Inc.	\$383,636.00
Engineer's Estimate	\$237,545.50

Based on the low bidder's prices, the estimated funding for the project is as follows (includes contingencies and engineering fees):

Special Assessments (Rick Cashin)	\$	162,300.00	52.7%
Special Assessments (RVS Leasing)*	\$	145,500.00	47.3%
Tot	al \$	307,800.00	100.0%

\*RVS has requested assessments to be deferred until their land is developed.

It is recommended to award to the low bidder, BCM Construction. Construction on the project is scheduled to begin in April/May and be substantially completed by the end of August, 2020.

**ALSO, BE IT RESOLVED,** that the City Administrator is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposit of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.
