Drug Arrests

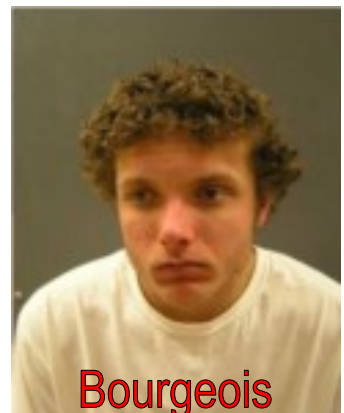
On Thursday, February 18th, agents of the **Cannon River Drug and Violent Offender Task Force, Detective Scott Duncan, Officer Justin Hunt** and **RCSO Deputy Steve Bauer** with **K9 Tank** were assisting Northfield PD **Detective Brian Kramer** with the execution of a search warrant related to a theft investigation at a Faribault residence. While searching, officers discovered items indicative of drug sales and use. One of the agents then obtained a second search warrant related to the narcotics. Agents discovered a scale with methamphetamine residue, a glass pipe containing water that tested positive for methamphetamine and loose prescription pills. Agents also noted the drug items were in reach of two children that were in the residence. The suspect, **Jacqueline Winter**, 35, was arrested and jailed. She was charged with two counts of 5th degree Controlled Substances and Storing Meth Paraphernalia in the Pres-

ence of a Child. Her bail was set at \$3,000 with conditions.



On Tuesday, February 23rd, **Officer Adam Marvin** stopped to check on an occupied vehicle at a local store late at night. The two occupants stated they were homeless and evasive in their statements to Ofc. Marvin. **Officer Mike Thul** and **K9 Chase** arrived to assist. Ofc. Marvin determined the occupants may be involved with narcotics possession and **K9 Chase** performed a sniff of

the vehicle, alerting to the presence of narcotics. The officers located suspected heroin, methamphetamine and drug paraphernalia in the vehicle. One of the occupants, **Raymond Bourgeois**, 21, told the officers the drugs were his. He was arrested and charged with two counts of 5th degree Controlled Substances, Possession of Drug Paraphernalia, and Obstructing Legal Process. He was released on his own recognizance.

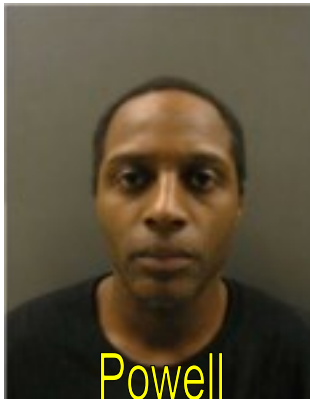

Domestic Assault Arrests

On Saturday, February 20th, officers **Mallory House, Keith Voegel, Said Hilowle** and **Adam Marvin** were dispatched to a local convenience store for a reported disturbance. Officers met with a woman who told them that she had been assaulted by a male, and that she had jumped out of his moving car to get away. Officers could see bruises and cuts on her. She told the officers that she knew the suspect, **Franklin Powell**, 41, and had been arguing with him earlier in the evening while riding in a car, and he punched her at one point. She got out of the car, but he returned a short time later and picked her up. She stated he was upset with her and was driving recklessly, not letting her get out of the car. As he slowed down to turn, she jumped out of the car in an attempt to flee. After she jumped out of the car, he pulled her back in and continued driving. When he stopped to buy cigarettes, she ran into the store and alerted the clerk who called 911. Powell was found sitting in his car, and was arrested without incident. He was charged with Domestic Assault (felony) and False Im-

prisonment. His bail was set at \$15,000 with conditions.



On Sunday, February 21st, **Officer Josh Sjodin** met with a woman at the police department who reported she had been assaulted by her husband. She told the officer her husband had been drinking when he came home. She stated she was trying to clean up a mess when her husband pinned her to the floor and began choking her. She told the officer she got away from the suspect, **Steven Johnson**, 34, and left the residence to come to the police department. Ofc. Sjodin went to the residence, assisted by **Officers Tony Kuchinka, Tom Mueller** and **Sergeant**

Matt Knutson, and found the suspect asleep. Johnson told the officers that he did not remember anything after returning home. He was arrested and jailed without incident. While at the jail awaiting booking, a Correctional Officer overheard him talking to his wife by phone and making threats to her. He was charged with Domestic Assault by Strangulation and Domestic Assault. His bail was set at \$5,000 with conditions.
