Drug Arrest

On Tuesday, August 14th, Officers Karl Willers, Mike Thul, Ben Johns, Michael Shuda, Detective DJ Skluzacek and Sergeant **Brandon Gliem** responded to a concerned citizen's report of a possible drug sale. On their arrival, officers found three males inside a vehicle matching the citizen's description. While talking with the three, Ofc. Willers could smell the odor of marijuana coming from the vehicle. The driver admitted to Ofc. Willers that he did smoke marijuana in the car, likely caus-

ing the odor. As officers removed the three, one of the males took off on foot. He was quickly apprehended by Ofc. Shuda and Sgt. Gliem. During the chase, a second male also fled on foot and was not found. Inside the vehicle, officers found 14 Oxycodone pills. The driver of the car, Andres Sanchez, 18, was arrested and charged with 5th degree Controlled Substances and his bail was set at \$3,000 with conditions. The runner, Thok Chuol, 27, was cited for Fleeing Police on Foot and released.



Identity Crisis

While patrolling on Thursday, August 14th, Officer Josh Sjodin ran a check of a license plate on a vehicle in traffic. While the plate displayed a 2019 sticker, a computer check showed the plate expired in April 2018. He stopped the vehicle to investigate. The driver stated she did not have her license with her and provided a name and birthdate. Ofc. Sjodin checked the name, and noted the license photo did not match the driver. Officer Mike Thul arrived to assist. Upon further



investigation, she provided her correct name, and Ofc. Sjodin learned he had an outstanding arrest warrant. Rebekah Jilk, 33, was charged with Providing a False Name to a Peace Officer and her bail was set at \$500. Ofc. Sjodin also discovered the tabs displayed on the license plate belonged to Jilk's passenger and were registered to a different vehicle. The passenger, Jesse Cowdin, 30, was cited for Intent to Escape Motor Vehicle Tax and released from the sce-

ne.

Domestic Assault Arrest

On Tuesday, August 14th, Officer Mike Thul, Ben Johns, Kara Christensen, Josh Sjodin and Michael Shuda responded to a reported domestic. Several family members reported the suspect was intoxicated and threatening to assault his wife, nephew and brother-in-law. The suspect, Otto Martin Chilel, 36, was arrested and jailed. Detective Josh Alexander interviewed other family members the following day and obtained more



information about the suspect's actions. The family members stated they were all afraid of the suspect because of previous assaults. Martin Chilel was charged with Terroristic Threats (three counts), Domestic Assault (two counts), and 5th degree Assault. His bail was set at \$50,000 with conditions.
