Warrant Arrest

On Friday, November 2nd, **Officer Brittany Carstensen** responded to the courthouse regarding a person who was the subject of an arrest warrant. Ofc. Carstensen met with Sabrina Henry, 38, and confirmed that Steele County had issued an arrest warrant for her. Henry was taken into custody without incident. When Ofc. Carstensen searched her purse, she

found several loose pills, which Henry identified as non-controlled substances. At the jail, the pills were identified as Oxycondone, and Henry admitted she did not have a prescription for them. Henry was charged with 5th degree Controlled Substances and her bail was set at \$15,000 with conditions.

DANCO Arrest

On Sunday, November 4th, **Officer Chris Tonjum** investigated a driving complaint. While the complaint was unfounded, he noted the driver was the subject of a Domestic Abuse No Contact Order (DANCO), barring him from contact with the victim and her residence. The DANCO had been issued just 10 days earlier after Roush had been arrested and charged with Domestic Assault and Theft involving the same victim. A short time later,

Ofc. Tonjum saw the vehicle parked at the victim's residence, and saw both the male and victim loading things into the truck. He stopped to investigate, and the male, Brett Roush, 40, stated he was just picking up Halloween decorations. He was informed that he was in violation of the DANCO and arrested. He was charged with DANCO Violation and released on his own recognizance by the court.

Warrant Watch


This week, we're looking for Maurice Williams, 34. He is the subject of an arrest warrant for failing to appear for sentencing on drug charges, as well as a second warrant out of Benton County. Williams is 5'8" tall, weighs 125 pounds, has black hair and brown eyes.



Also the subject of an arrest warrant is Jennifer Marx, also known as Jennifer Ohm. She is the subject of a probation violation warrant resulting from a drug conviction. Marx is 5'5" tall, weighs 120 pounds, has brown hair and green eyes.




Next, we're looking for Jairo Gutierrez-Rodriguez, 31. He is the subject of multiple warrants for failing to appear on
