

**“Automated Payments” Sweepstakes
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF SWEEPSTAKES: The “Automated Payments” Sweepstakes (the “Sweepstakes”) begins at 12:00 am Eastern Standard Time (“EST”) on July 15, 2020 and ends at 11:59 pm EST on September 15, 2020 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open only to persons who are legal residents residing in the state of Minnesota in the city of Faribault who are eighteen (18) years of age or older at time of entry (the “Entrant”). Officers, directors, managers and employees, including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside and members of the same household, whether or not related) of Springbrook (the “Sponsor”) its respective parent, subsidiaries, affiliates and related companies; licensees, distributors, retailers, dealers, printers, advertising and promotion agencies; consultants and agents; and any others engaged in the development, production, execution or distribution of this Sweepstakes, including National Sweepstakes Company, LLC (the “Independent Administrator”) (herein, all collectively referred to as “Sweepstakes Entities”) are not eligible to participate or win a prize. HOW TO ENTER: Entrants who are new or existing City of Faribault Utility customers may receive one (1) entry by signing up for automatic bill payments during the Sweepstakes Period. New and existing City of Faribault Utility customers must visit <https://faribaultutilities.merchantrtransact.com/> (the “Website”) during the Sweepstakes Period. If you are an existing online customer, sign in and select “Sign Up for Automatic Payments” to receive one (1) entry into the Sweepstakes. If you are a new customer, select “First Time User”. Then, create your profile by submitting all of the information requested. Once you have submitted your information, you can sign in and select “Sign Up for Automatic Payments” to receive one (1) entry into the Sweepstakes. An Entrant will receive one (1) entry into the Sweepstakes based on the date and time in which he/she signed up for Automatic Payments.

There is a limit of one (1) entry per Entrant for the entire Sweepstakes. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, telephone numbers, identities, and/or any other methods (including, but not limited to enrolling and un-enrolling in Autopay services for the purposes of obtaining additional entries), will void that Entrant’s entries and that Entrant may be disqualified from the Sweepstakes. In the event of uncertainty as to the identity of an Entrant entering, the Entrant will be disqualified.

DRAWING/ODDS OF WINNING: On or about September 17, 2020, one (1) grand prize winner (the “Grand Prize Winner”) will be selected from all eligible entries received during the Sweepstakes Period in a random drawing conducted under the supervision of the Independent Administrator, an independent judging organization, whose decisions are based on their sole discretion and interpretation of these Official Rules, and are final and binding in all respects. Odds of winning depend upon the total number of entries received during the Sweepstakes Period.

PRIZES:

Grand Prize: One (1) grand prize of an iPad™ 6 with Retina Display (the “Grand Prize”) will be awarded. Total approximate retail value (“ARV”) of the Grand Prize is \$330.00.

Name of the prize manufacturer is used solely for prize identification purposes. No endorsement, sponsorship, authorization or affiliation with Sponsor, its goods/services or this Sweepstakes is intended or implied thereby.

Sponsor reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
